1. DESCRIPTION

The Wellness Experience, an initiative of the Piscina & Wellness Barcelona Trade Fair, organised by Fira de Barcelona, is a real operating space of a sustainable Wellness from an economic, functional and environmental point of view, in which equipment, products, installations and key materials of the sector will be exhibited in a dynamic way. An opportunity for exhibiting companies to present the latest trends and developments in the wellness industry. A successful model, endorsed by experts, with the aim of providing ideas and solutions in design, management, marketing and products. This space will be accessible and free of charge to all visitors to the fair.

The organiser reserves the right to cancel this activity if, at its discretion, there are not enough requests from the exhibiting companies to provide a show with a sufficiently interesting content for visitors to the fair.

2. EXHIBITION DATES

The Wellness Experience will take place during the Piscina & Wellness Barcelona Trade Fair 2019, i.e. from 15th to 18th October 2019.

3. PARTICIPATION

All companies exhibiting at the Piscina & Wellness Barcelona Trade Fair 2019 can present their products in this space.

In addition, they must meet the requirements indicated in the registration section.

4. REGISTRATION

Interested parties must register on the platform designed for this purpose, where they will find the forms to be completed and send the required documentation through the platform, before the 14th June 2019.

Registration on the platform is required in order to send the following documentation:

- A. Registration through of the registration form that will appear together with the fair rules on the website of Piscina & Wellness Barcelona (http://www.barter.es/e/piscina/CallMaterials2019.html).
- B. Along with the registration form it is essential to attach additional documentation (product description or technical sheet, photograph, plans, benefits of the product, etc.) so that the Technical Committee has the maximum amount of information to evaluate the product. A maximum of 5 products may be presented in this registration form

5. ACCEPTANCE

Registration will be effective once the product has been accepted by the Technical Committee.

Acceptance criteria:

a) Novelty, design, innovation, economy, sustainability and functionality to the project.

In addition, the fact that the exhibiting companies are the manufacturers of the product or equipment, or whether they are just the distributors, will be valued.

The fair will inform by e-mail, the contact person indicated by the exhibiting company in the registration form, about whether the product has been accepted for their participation in the Wellness Experience. This notification will be sent from 9th September onwards.

6. REGISTRATION FEE

The registration fees are as follows:

- Fair exhibitors: Free (maximum 5 products)
- Co-exhibitors: €500 + 10% VAT for each product accepted and presented*
- Exhibitors and co-exhibitors of the fair, once selected by the selection committee, will be able to contract the various Partnership Wellness options.
- In cases where the material necessary for the development of the Wellness Experience area is not proposed by any exhibiting company or co-exhibitor, Fira de Barcelona may propose an external company to supply it.

The number of products accepted by an exhibiting or co-exhibiting company is subject to the availability of space and its adaptation to the principles of innovation, sustainability and digitalisation.

7. PRODUCT EXHIBITION

The products will be exhibited in the Wellness Experience area according to the project defined for the area by the fair. It is the responsibility of the Organiser, through the Wellness Experience Committee, to indicate to each exhibitor where their product will be located within the Wellness Experience.

For this reason, it is essential to indicate on the registration form the dimensions and weight of the product and the time required for setting up the display, in order to define the assembly times.

If no such information is received, the organisation will not be able to evaluate the possibility of the participation of the product in the Wellness Experience.

^{*}The participation in Wellness Experience will be invoiced directly by Fira de Barcelona to the co-exhibiting companies, once the quantity of accepted products has been determined.

Each accepted material or product must be physically accompanied by an explanatory poster; the Organisation must send this to the exhibiting company once its proposal has been accepted by the Technical Committee. This poster, size A4, will be sent to those selected and must be filled in by each company with the necessary details and in at least one of the languages indicated (Catalan, Spanish or English), and will be placed by the Organisation in the position and location that the Wellness Technical Committee considers appropriate.

The exhibited products will be set up by personnel from the exhibiting company itself, who will take care of their maintenance during the trade show days. It should be possible to put the exhibited material or product into operation to perform demonstrations during the exhibition period.

To this end, exhibitors must take Fira de Barcelona's general assembly and dismantling regulations into account, which are available in the Exhibitor's Area, accessible from the fair's website(http://www.piscinawellness.com).

8. EXHIBITION ASSEMBLY

The physical installation of the products to be exhibited at the Wellness Experience will be carried out during the assembly days established by the fair and according to the order established by Fira de Barcelona, together with the Wellness Experience Technical Committee.

From 9th September, the fair will contact exhibiting companies to inform them of the location assigned to their product, the day of assembly and the needs during assembly, whilst the fair is being held and the dismantling.

The exhibiting company will be responsible for providing all the technical and human resources required for the installation and dismantling of the equipment in the assigned spaces and will bear any related transport, installation or positioning costs.

The exhibiting company is responsible for obtaining and maintaining at its own expense the necessary authorisations, permits or licenses from any authority or public or private third party, which are necessary for the exhibition of its products at the Wellness Experience.

The exhibiting company is directly responsible for any direct or indirect damage that may be caused during the fair to people, property or public or private services due to the actions, omissions or negligence of the personnel at its service and of its organisation, or for any claim relating to the said damages. Fira de Barcelona is exonerated from any liability that may occur due to the foregoing concepts, except for any incidents that may arise in relation to the services provided directly by Fira de Barcelona to exhibitors and visitors.

The exhibiting company must comply with the legal regulations in force regarding health and prevention of occupational risks. The exhibiting company shall be responsible for the salaries of the personnel, the General Social Security Scheme contributions, Mutual Insurance Company and Insurance against Accidents at Work costs, as well as any other obligation deriving from the labour legislation in force, and shall be solely responsible for compliance with such terms in relation to the labour contracts of the personnel, if any, contracted at its orders and in relation to the regulatory bodies on the matter.
